Licenses are valid for the calendar year only, unless otherwise suspended, revoked or extended. Applications for new and renewal licenses will be provided by the Member Clubs of ACCUS.

If you are participating in an event outside of the U.S. please be aware of all FIA International Sporting Code regulations found on the FIA website at [www.fia.com](http://www.fia.com).

Additionally, be aware of the Therapeutic Use Exemptions (TUE) process as outlined in Appendix A of the FIA International Sporting Code.

If the applicant wants to allow his/her personal data to be collected and processed in the FIA World Accident Data Base by accepting the WADB Declaration of Consent, contact ACCUS for the applicable form. Accepting or Not Accepting has no bearing on the issuance of this license.
